AIIMS DEOGHAR invites Expression of Interest (EOI) from specialized agencies having experience in planning, installation, maintenance and implementation of "In Building Networking Solution" other similar related works in reputed Govt. or private institute. The Minimum Eligibility criteria are defined in clauses 1, 2 & 3 below:

- 1. The applicant should be a well-established specialized agency having experience in planning, installation, maintenance and implementation of "In Building Networking Solution" other similar related works in reputed Govt. or private institute.
- 2. The applicant must have at least 03 years experience in planning, installation, maintenance and implementation of "In Building Networking Solution" other similar related works in reputed Govt. or private institute, and they have Annual Turn Over of not less than Rs 10 lakh in each of last three years. Work completion certificate from Private institute /reputed Govt. institute or Dept. will be attached.
- 3. Should have solvency of Rs.30 lakhs certified by a Scheduled Bank and obtained not earlier than three months before the date of submission of EOI.

Agencies not meeting the minimum eligibility criteria shall be summarily rejected. AIIMS Deoghar may ask any other document (not mentioned in this EOI document) from the parties as and when required, for evaluation of credentials of the bidders.

Location of work: The location of work will be in different locations in the AIIMS Campus like Hostel Area/ Academic Area/ Hospital Area/ Residential Area etc.

Kindly note that the views presented above is the proposed plan and basic concept of in planning, installation, maintenance and implementation of "In Building Networking Solution" subject to modifications for improvements. However, decision of technical committee constituted by AIIMS Deoghar will be final in this respect.

General Terms and Conditions:

- i) Vendor should not be blacklisted by any Govt. Organization for which an affidavit on Rs. 100/- Non Judicial Stamp is required.
- ii) Electricity Charge to be charged from vendor, if required, as per actual consumption and as per commercial rate. The vendor will have to install a submeter on their own cost.
- iii) Rental to be charged from vendor for indoor space, if required, as per other vendors already paying or as per nearest municipal rate. ED & CEO, AIIMS Deoghar will reserve the right to decide either of one for rent.
- iv) Vendor/Bidder must have proper license issued from Department of Telecommunication (DOT), Govt. of India for providing IBS/ Wireless Services.

Scope of complete work: In general, the entire work shall consist of the following three stages:

Stage-I (EOI by Vendors):

- Expression of Interest (EOI) from specialized agency meeting minimum Eligibility criteria are defined in clauses 1, 2 & 3.

- Technical evaluation committee appointed by the competent authority of AIIMS Deoghar shall shortlist the agencies based on minimum eligibility criteria and terms and conditions specified in the EOI.
- The interested agencies give the detailed presentation before the Technical evaluation committee appointed by the competent authority of AIIMS Deoghar on scheduled date decided by AIIMS Deoghar.

Stage-2 (Evaluation of tenders):

- Bids to be submitted along with Tender Fee and all the required documents and proof asper the requirements indicated in the tender documents
- Period of completion / Time limit for completion of work shall be 120 days from acceptance of work order.
- Technically accepted, financially rental decided by AIIMS Deoghar and accepted by the vendor shall beconsidered for award of work.
- -Any shifting of present equipments and fittings in the place of work will be carried outby the agency at their cost.

Stage-3 Evaluation, short listing of vendors & issue of tender documents (2 part bidding system):

- Shortlisted agencies shall be called for making a presentation at AIIMS Deoghar on the date and time intimated by the institute. The presentation should clearly spell out following points:
- 1) Brief history and financial strength (turn over) of the company. Similar work already executed.
- 2) The representatives of agency will give details presentations regarding his plan, installation, maintenance and implementation of "In Building Networking Solution" at AIIMS Deoghar.
- 3) Design considerations along with suggestions for improvements, for this work, for achieving, better performance of the facility. Such information shall be based on the vendor's completed work experience and meeting all the norms and regulations.
- 4) Brief description, specifications of materials, the source of materials will be presented by the agency.

The presentation will be followed by technical discussions with the AIIMS Deoghar committee. The marking criteria to be followed in following manner:
